MINUTES OF THE ANNUAL GENERAL MEETING OF THE GALLOWAY CATTLE SOCIETY, held on Friday, 31<sup>st</sup> May 2019 in the Board Room, Harrison & Hetherington Ltd, Rosehill, Carlisle at 1.00pm

Mr John Finlay Chairman of Trustees, presided, and in attendance Mrs D Goldie (Secretary)

Present: Mr A McConchie, Mr G Noble, Mr D Cornthwaite, D & D Heath, Mr R McTurk, Mr S McKinnon Mr P Hunter Blair, Mr A Brown, Mr MJ Ross. Mr A McClymont, Mr D Maxwell, Mr A Waugh, Liz Wilkinson, Messrs B & B Douglas and Mr K Laurie.

- **1. Apologies:-** Messrs I Finlay, W Forbes, A McMillan, J Smyth, S Redman, A Tullie, Miss M Howie and Mrs S McKinnel.
- **2. Minutes**: The Minutes of the Annual General Meeting held in the Kings Arms Hotel, Castle Douglas on 23<sup>rd</sup> May 2018 were approved by Mr A McClymont and seconded by Mr S McKinnon. The Chairman signed these Minutes.
- **3. Report of Council**: Mr John Finlay stated that the majority of the Society's activities had been covered in the 2018 Breed Journal, he then read out the following Trustees' report. The Galloway Cattle Society had another successful year, the Society's sales had been well supported, Troloss Farms had topped the bull trade again and heifers were very well bid for at both Castle Douglas and Carlisle.

The summer shows were well attended by both exhibitors and spectators and a special thanks to our exhibitors who take the time to attend these shows. At the Royal Highland show, the Society was represented with a stand and marquee. Congratulations were extended to the Troloss Team who won the championship with Blackcraig Sid and Jason and Sarah Wareham who received the reserve championship award with Troloss Legend. At the Yorkshire show, the Ross Team from Romesbeoch received the championship with Nerys 1306 of Romesbeoch and Harvey's Zsa Zsa from George Harvey received the reserve title.

The Society has been represented at various events and beef events around the country and our thanks go to everyone who helped and offered cattle for stands. The 2018 Tullamore Show was a new event and we thank Brendan and Barry Douglas for their support at this event, their Galloways which were exhibited on the stand created a lot of interest and with new interest from Irish farmers the Society will capitalize on events such as this. In the last few weeks, the Society had attended Beef Expo and Scotland's Beef Event, at both events excellent cattle were on display and they were much admired by visitors to the events.

The Galloway Beef Scheme is progressing, the Quality Assurance scheme is now underway with members being assessed under the new rules, in recent months Galloway Burgers had been sold in Scottish Aldi stores, the Galloway Pie and Galloway Beef Web site had been launched and future PR events are being launched. The last learning trip is planned for Green Week in Germany and this will be advertised in coming months.

Mr Finlay then thanked his fellow Trustees for their help and support, he also thanked Dorothy and Miss M W Lothian for their help in organising the office and Andrew McConchie who is called upon to attend shows and events.

This report was approved by Mr P Hunter Blair and seconded by Mr A Waugh.

**4. Accounts: -** The Chairman called on Mr Andrew McConchie to give the report of Auditors and the Financial Statements. He presented the following report:-

As expected, due to the ongoing promotions, the Income and Expenditure account for the year end showed a deficit of £3828. Turning to the Society's income, overall total income showed a decrease of £573 on the year, registration fees and subscriptions decreased by £1920 and £603 respectively, levy on sales increased by £1212, and all other income was comparable to 2017. Our income from Society's investments is a welcome income source as income from our investments was nearly a 6<sup>th</sup> of our total income. On the expenses side, total expenses were £44533, £5571 increase on the year before, our largest expense was publicity and advertising of £14601, up £8294 on the year. This was due to the extra work and expenses with the Galloway Beef project, which was now reaping rewards as the first Galloway beef pie was being launched at the Galloway Sale, all other expenses were comparable to 2017, except for postage as this saw an increase of £296 due to an extra mail shot and increased postal charges. There was also no Legal and professional fees due to the new constitution being a one off expense in 2017. Turning to the Balance Sheet, the overall funds of the Society were £217082, this showing a decrease of £22035 on the year, this was due to the decrease of quoted investments from £214, 509 to £186,876. Also sundry debtors and trade creditors show increases due to more registrations in December and the Leader grant being still to claim.

Regards to our investments, a request was made from Speirs and Jeffery to undertake decisions on our portfolio without consultation from Mr McConchie. This was agreed and Mr McConchie will inform Speirs and Jeffery of this decision. It was noted as from the 1<sup>st</sup> June 2019 Speirs and Jeffery our stock broker merged with Rothbones Brothers.

Mr McConchie also explained that in 2020 it is the intention not to post out hard copies of Accounts to members, this information will be posted online on our web page and to anyone who requests a hard copy. At this point it was suggested hard copies will be posted to all Trustees, this was agreed and the Secretary will send all Trustees a copy.

The Chairman asked for questions: Mr S McKinnon asked how Speirs and Jeffery received their fee, Mr McConchie confirmed that was a percentage of total income and therefore in their best interest to invest wisely. It was also confirmed the Society receive reports of investment and income quarterly.

As there were no further questions the report was approved by Mr S McKinnon and seconded by Mr A McClymont.

- 7. Any other Competent Business: Several questions were asked about the Quality Assurance Scheme and the promotions of Galloway Beef, Mr Scott McKinnon gave the following update on the Scheme. The Quality Assurance Scheme was now underway and over 20 farms had been assessed. This was a bolt on to the members existing Quality Schemes and this included the Red Tractor Scheme in England and the IMC in Ireland. We were pleased to announce Aldi had sold out of Galloway Burgers. Further talks with a leading supermarket at the forthcoming Royal Highland Show have been arranged to develop the Galloway range sold in stores. Regards to Galloway Beef, in the last few months, a Galloway pie had been launched along with the Galloway Beef web page and it was hoped to secure a premium at the farm gate for our product. Members were reminded that the Galloway scheme was for 50 % Galloways, either dam or sire had to be registered with the GCS.

As there was no further business the meeting closed at 1.45pm, with a vote of thanks to the chair from Mr A McConchie.
